

Capacity Release

Firm service transportation and storage customers may create offers to release all or a portion of their primary or secondary capacity on the pipeline to another shipper for a specified period of time, path (transportation)/location, and rate. The capacity release section of 1Line provides a means for customers to create offers, submit bids, view awards and recall capacity.

Create an Offer

The **Create Offer** page is initially loaded with only the **Header** section displayed. Proceed to fill in the fields as requested; note the required fields marked with a red asterisk.



1. Select Navigation>Capacity Release>Offers>Create Offers.

The Create Offer page has five sections: **Header**, **Terms**, **Bidding Details**, **Loc/Qty & Rates**, and **Contact Info**. To progress from section to section, use **Enter**.

Bid on an Offer


